The University of Michigan Team consists of representatives from medicine, social work, law, psychiatry, psychology, and nursing. The team is responsible for the identification, evaluation, and coordination of all cases of suspected child abuse and neglect. In this capacity, it coordinates comprehensive medical and psychosocial evaluations of children and their families. It then assists with treatment planning and coordination of services in the community.

Workshop Sessions

Participants may elect two of the five afternoon workshop sessions. Each workshop will be presented twice. As enrollment is limited, registrants are urged to rank their preferences 1-5 on the course registration form.

Workshop I

Evaluation and Management of the High Risk Family

The multidisciplinary team assembled for this session will differentiate between abuse and neglect in high risk families, ~~demonstrate the evaluation process~~, and discuss strategies for intervention with these families. *(Prevention emphasis strategies)*

Workshop II

Failure to Thrive in the Young Child

This session will explore the multidisciplinary team approach to the identification and inpatient management of Failure to Thrive children.

Workshop III

Is it Child Abuse? Interviewing the Family

This workshop will focus on how to recognize the family that should be interviewed; interview guidelines for nurses, physicians, and social workers; how to decide when to report to Protective Services; and a demonstration of an interview.

Workshop IV

Interdisciplinary Approaches to Child Sexual Abuse

Topics for discussion in this session will include: physical evaluation — its advantages and limitations, psychosocial assessment and differential diagnosis, the role of the physician with the child and family, the role of public health, protective services, and legal interventions, and prognosis and treatment.

Workshop V

Assessment of the Burned/Abused Child

Identification of burn injuries as child abuse and the implications for immediate and long term treatment will be discussed in this session.
