Professionals working in the area of child abuse and neglect face a number of diverse and difficult problems. One of the most critical is the increasing demand on service with a marked decrease in resources to meet those demands. A second is the increasingly complex cases professionals are faced with – families with multiple problems such as substance abuse, domestic violence, physical and developmental disabilities, and mental illness. Families from different cultural and religious backgrounds often require special techniques to assist them. Child abuse professionals may have few peers, may feel isolated from essential contact with other professionals, and have little support and encouragement for what is often difficult work. Specific expertise on certain topics may not be accessible in their geographic area, and different areas may face a varying level of coordination of services. Professionals in this field may face a high level of burnout due to the pain and stress of continuously confronting child abuse and neglect.

## Program Objectives

This conference has multiple goals:

The first is to enhance awareness among professionals working with children and families regarding different aspects of the issue of child abuse and neglect.

The second is to build concrete skills for the identification, assessment, treatment and prevention of child abuse and neglect and to develop methods to coordinate services.

The third is to bring professionals from the entire state together in a forum to share information and ideas about child abuse and neglect and to build support networks.

Experts from throughout the country will address participants as a whole and in small group settings through panels, workshops and multi-media presentations. Course participants will have the opportunity to learn about other programs and methods through information tables and booths.

Participants will have the opportunity to encounter state-of-the-art information about child abuse and neglect to aid them in developing new perspectives in their work and the chance to share ideas and resources with colleagues throughout the State of Michigan.

The conference is designed for professionals working with families, including: law enforcement personnel, physicians, nurses, mental health professionals, protective services workers, prevention specialists, attorneys, teachers, social workers, psychologists and psychiatrists.

## WORKSHOPS SESSION I.

- Children and the Probate Court**  
What type of cases go to Probate Court. What to expect from Probate Court. How to prepare for court. How to be an effective witness.

- Perinatal Nurturing Programs**  
This presentation will focus on the perinatal nurturing program, a nine-week program that helps parents prepare for life with their baby. The program addresses the issues of:
  - Celebration of Birth and Preparation for Parenthood
  - Expectations and Adjustments to Pregnancy
  - Enhancing the Parent-Infant Bond
  - Adjusting the Family System to Include the New Member
  - Empathy, Needs and Spoiling

  - Prenatal Health, Nutrition and the Effects of Drugs, Alcohol and Smoking on the Baby

- Legislative Issues Impacting Children in Michigan**  
Representative Gire is an advocate for children and families. She is current Co-Chair of the Committee on Human Services and Children. She will discuss the legislative issues related to children and families in Michigan. Techniques of working with foster parents around management of difficult behaviors will be discussed and demonstrated. Assessment of behaviors within the context of a child's developmental history and family experience will be a focus.
